His Will was proved at London the second day of August in the year of our Lord One thousand seven hundred and fifty eight before the Worshipful Esq^r Edward Dorrer of Laws a surrogate of the Right Worshipful George May Doctor of Laws one of the Justices or Commissioners of the Privy Council of Great Britain lawfully constituted by the Oath of English Judges the Executor named in the said Will to whom Administration was granted of all and singular the Goods Chattels and Credits of the said Testator having been first sworn duly to administer. f. 63.

Aron Louzada In the Name of God Amen

I Aron Louzada of Bury Street near Mary Ax London an Merchant being of sound Mind Memory and Understanding do make my last Will and Testament as followeth first I recommend my Soul to God my Creator hoping through his Divine Mercy forgiveness of my sins my Body I would have buried in the new Burial place of the Portuguese Jews at Mile End near the remains of my late sister Leah Louzada and as to my worldly Estate wherewith it hath pleased God to bless me I dispose thereof as followeth that is to say I desire that all my just debts and funeral expences may be first paid and satisfied and subject thereto I will and order that there shall be divided by my Executors hereafter named among the poor of the Portuguese Jews the sum of forty pounds at the times and in manner following to wit Ten pounds on the day of my Burial Ten pounds more on the seventh day Ten pounds more on the thirtieth day and the remaining Ten pounds in seven months next after my Burial Also I give to my sister Sarah Louzada and to Mr. Moses Isaac Levy and Mr. Isaac Abraham Louzada my Executors hereafter named the sum of seventy pounds in Trust to be paid by them as followeth that is to say twenty pounds to the Parnassim and Gabay of the Synagogue Ten pounds to the Treasurer and Parnassim of the Society called Shamm Ten pounds to the Administrator and Treasurer of the Society of Orphan Boys Ten pounds to the Treasurer and Parnassim of the Society of Betholam all of the Portuguese Jews in London and twenty pounds to the Parnassim and Gabay of the Synagogue at Port Royal in Jamaica aforesaid belonging to the Portuguese Jews I give to my late wife Abigail Levy the wife of the said Mr. Moses Isaac Levy to my nephew Mordecai Rodrigues Lopes of Kingston in Jamaica aforesaid and to my niece Abigail Pereira of

Kingston in Jamaica aforesaid one hundred pounds a part I give to my Cousin Mr. Nathaniel Abenatar of Kingston aforesaid and to her sister Mr. Ester Levy of the same place fifty pounds a part and I give to the Children of their late brother Aron Aben fifty pounds equally to be divided

among them share and share alike Also I give to my
 Cousin Aron Baruh Louzada of Barbados and to his
 Brother Jeremy Baruh Louzada fifty pounds a piece and
 to the Children of their late Brother David Baruh Louzada
 also give fifty pounds equally to be divided among them
 share and share alike also I give to Mr Ester Comey and her
 daughter Marcell Comey Ten pounds a piece and I give
 to Mr Ester Martin and to Mr Sarah Ramo the wife
 of Aron Ramo of London Ten pounds a piece Also I give
 to Mr Simoa Rodrigues Alexandra twenty pounds and I
 give to Mr Isaac Baruh Louzada Ten pounds and to
 Adama Ramo my sisters Cook in case she shall be
 living with her at my death I give five pounds and my will
 is that the said several legacies except the legacy of
 forty pounds to the poor be as aforementioned within is
 to be paid at the times herinbefore directed shall be paid
 within three months next after my decease and I give devise
 and bequeath all the rest and residue of my Estate
 whatsoever as well real as personal unto my loving
 sister Sarah Louzada her heirs Executors and Administrators
 she thereout paying my debts funeral Expences and the
 several legacies herinbefore by me given and I make
 and appoint my said sister and also the said Moses Isaac *Isaac and Isaac*
 Baruh Louzada Executors of this my will and I do hereby
 revoke all former Wills and Codicils by me at any time
 heretofore made and do declare this to be my last will and
 Testament in witness whereof I have herunto set my hand
 and seal this twenty eighth day of April in the year one
 thousand seven hundred and sixty eight Aron Louzada
 signed sealed published and declared by the said Aron
 Louzada the Testator as and for his last will and Testament
 in the presence of us who in his presence and at his
 request and in the presence of each other have subscribed
 our names as witnesses hereto. In: Heaton Rob: Purchall

 having been first sworn duly to administer. Power reserved
 of making the like Grant to Sarah Louzada Spinster the
 sister of the deceased and other Executor when she shall
